OFFICIAL RULES

These are the official rules (the "Official Rules") that govern the BHHS Pawfect Home Contest (the "**Contest**") and the relationship between you and the Sponsor (as defined in point 1 below) in relation to the Contest. 3. **Eligibility:** The BHHS Pawfect Home Contest is open only to legal residents of the 50 United States and the District of Columbia, Canada, Mexico, the United Kingdom, Portugal, Greece, and Spain, who have mental capacity and are at least eighteen (18) years of age or the age of majority in their country, province, or state of residence, whichever is older. (“**Promotion Period**”). Administrator’s computer is the official clock for this Contest.

You will be directed to complete the online entry form. You will be asked to provide your full name, e-mail address, city and state/province/country (your e-mail address will be used to contact you only if you are a potential Grand Prize winner). A given individual may only enter at the Website corresponding to his/her country of residence; any attempt to enter at any other Website will result in the entry being void and not accepted. You will be entered once into the Grand Prize Drawing for that Territory. A U.S. resident will automatically be entered in the Grand Prize Drawings for the U.S. and North America Territories. Sharing will only result in provision of Bonus Entry if (a) the Share option on the Website is used and (b) an individual does not alter or modify the entry as shared. {As used herein, "Entry" refers collectively to Base Entry and Bonus Entry.}

6. Random Drawings/Selection of Winners:

Prize winners (each a “**Grand Prize Winner**”, collectively referred to herein as “**Prize Winners**”) will be selected from among all eligible entries received via random drawing. There will be five (5) separate random drawings, with two (2) Prize Winners drawn in the U.S. Grand Prize Drawing and one (1) Prize Winner drawn in each of the other three (3) Territorial Grand Prize Drawings; that is; North America (U.S., Canada, Mexico); United Kingdom/Portugal/Greece; Spain. All drawings will take place on or about June 14, 2022 and will be conducted at Administrator's offices. Grand Prizes (5 winners): Each Grand Prize winner will receive a custom-made pet home. Specifics of pet home will depend on winner's pet (for example, dog or cat) and the available space at specified outdoor location for installation of pet home, be it the winner's residence or another venue. Winner must be the owner of location for installation of pet home and/or have the written prior consent of owner(s) of location; winner may be required to furnish proof of ownership and/or such consents of owner(s) in conjunction with prize award and acceptance. Selected site for installation of pet home is subject to approval of Sponsor and third-party contractor in their sole discretion. Sponsor anticipates having pet home delivered/installed at applicable location within one (1) year of winner verification, with the understanding that this is a projected deadline and in no way binding upon Sponsor under any legal theory. Sponsor will advise winner of delivery date/installation date (which may not be the same) when established; it is winner's sole responsibility to be available at such

time(s), with the understanding that contractor may require several hours or more to install pet home. Winner must provide contractor safe and uninterrupted access to specified location for installation of pet home during such time period and agrees to fully cooperate with contractor relative to installation of pet home. Winner must prepare site for installation of pet home to contractor's reasonable satisfaction at winner's sole expense, including the removal of impediments, refuse and debris. Winner acknowledges and agrees that installation of pet home may result in damage to his/her property and, to the fullest extent permitted by law, winner releases and agrees to hold harmless Promotion Entities from any liability for same under any legal theory. Winner understands that any desired insurance relative to installation of pet home is his/her sole responsibility. Winner will also bear sole responsibility for maintenance and upkeep of pet home once installed. TO THE FULLEST EXTENT PERMITTED BY LAW, SPONSOR, ADMINISTRATOR AND PROMOTION ENTITIES MAKE NO WARRANTY, REPRESENTATION OR GUARANTEE OF ANY KIND, INCLUDING THE WARRANTY OR MERCHANTABILITY OR FITNESS FOR THE INTENDED PURPOSE, AS TO THE PET HOME INCLUDING BUT NOT LIMITED TO THE INSTALLATION OF SAME.

- 8. Winner Notification:** Each Grand Prize Winner will be contacted by email on or about June 14, 2022. Each Grand Prize Winner will be required to sign and return by email, within ten (10) business days of notification, an Affidavit of Eligibility, Release and Indemnification, a Publicity Release where allowed by law, and (if Winner is a resident of the United States, Canada or Mexico) the necessary paperwork for a background check (collectively, "**Contest Documents**"). If the Affidavit of Eligibility, Release and Indemnification, and Publicity Release, or any other portions of the Contest

Documents are not returned to Sponsor within the specified time period and the Winner cannot be contacted after two (2) attempts within ten (10) business days of notification, the Grand Prize Winner may be disqualified. If a Grand Prize Winner is disqualified for any reason, there will be no prize of any kind awarded and an alternate Grand Prize Winner will be drawn randomly from among all remaining eligible entries received for the corresponding Territorial Grand Prize Drawing.

If a Canada or Mexico resident's entry is selected in the North America Grand Prize Drawing, he/she will be required to correctly answer a mathematical skill-testing question without mechanical or other assistance of any kind, within a predetermined time limit, as a pre-condition to becoming a potential winner.

Except for liability in relation to a Non-Excludable Guarantee or any other liabilities which shall not be excluded under mandatory local law or public policy, the Released Parties exclude all liability whether arising in tort (including without limitation negligence), contract or otherwise, for any personal injury or any other loss or damage (including without limitation loss of opportunity or loss of profits), whether direct, indirect, special or consequential, arising in any way out of the Contest, including for failed, partial, or garbled computer transmissions, or for technical failures of any kind affecting the Contest in any manner, including but not limited to electronic malfunction or damage of any network, hardware, or software. The foregoing also includes any malfunction, error, or failure deemed by Sponsor or Administrator in the discretion of either party to impact the availability or accessibility of Entries submitted and/or shared by Entrants or the transmission or receipt of winner notifications. You agree not to damage or cause interruption of the Contest and/or prevent others from participating in the Contest. In respect of Entrants from the United Kingdom and Portugal, notwithstanding anything to the contrary, nothing in these Official Rules shall exclude or limit a party's liability for death or personal injury resulting from that party's negligence, for fraud or fraudulent misrepresentation or for any other matter where liability may not as a matter of law be limited.
